**legislation canada ca** Sep 02 2022 web Dec 23 2007 the citizenship act effective february 15 1977 replaced the 1947 act with a more equitable statute for example british subjects no longer received special treatment and dual citizenship became recognized there was only one provision

for automatic loss of citizenship limited to persons born in the second or subsequent generation outside

### **post graduation work permit eligibility requirements**

**canada ca** Jun 30 2022 web they have completed an academic vocational or professional training program at an eligible institution in canada that is at least 8 months in duration leading to a degree diploma or certificate they have maintained full time student status in canada during each academic session of the program or programs of study they have completed and [designated language testing organizations canada ca](#) Jan 14 2021 web designated language testing agencies note the tef canada test is the required test by ircc however officers should accept tef results if the test was taken before march 1 2020 tef results for tests taken on or after march 1 2020 will not be accepted and the application can be rejected
